The farm is 75.758 acres and they are wishing to open a Conference Center (William's Trace Farm & Conference Center) in a restored dairy barn. The anticipated uses for the barn are:

- 1. One day or multiple day conference center for university, school system, or regional business
- 2. Education center for schools, local groups, and senior centers
- 3. Social events to include weddings, wedding receptions, private parties, reunions, anniversaries, birthdays
- 4. Day trips for schools and senior center
