### Oxford Township Trustees Regular Meeting Minutes December 16, 2010

ITEM 149-10 Call to Order

At 7:00 p.m., Mr. Salmon called the meeting to order at the Oxford Township Building.

#### ITEM 150-10 Approval of Agenda

Mr. Frimerman moved, Mr. Salmon seconded the motion to approve the agenda as amended.

#### ITEM 151-10 Recognition of Guests

Mr. David Brown, Butler County Auditor's Office shared information with the Trustees regarding dog tag renewals and DTE 26 forms that can be filed by residents that experience a property loss as a result of a storm or fire. Mr. Brown stated a partial credit can be received on their tax bill while the property is being refurbished.

Mr. Coe Potter expressed concern over recent no parking signs in the right-a-way on Bonham and Shadowy Hills Drive. Mr. Potter stated the signs create a parking issue for those that want to hike the trails. Mr. Salmon stated the Trustees needed to be consistent and couldn't allow parking in some rights of way.

Mr. Jim Reid expressed similar concerns with the no parking signs as it relates to parking during routine maintenance.

After some deliberation, Mr. Salmon agreed to send Mr. Reed a letter requesting that the signs be changed to allow for authorized vehicles and support for temporary parking at Yager Stadium for those that wish to walk the trail. Mr. Potter stated he would also send a letter requesting consideration for a few parking spaces at Yager for access to the trail.

Mr. Jim Rubenstein stated that Mr. Randall Arendt will be in Oxford January 31, 2011 and February 28, 2011 to make a presentation and present a workshop to elected officials on Conservation Development. Mr. Rubenstein asked for a small sponsorship donation for the event.

### ITEM 156-10 Approval of 2011 Permanent Appropriations

ITEM 157-10 Approval of Property/Casualty/Fleet Insurance for 2011 Mr. Rowan presented the insurance renewal at a renewal price of just over 12% for 2011. Mr. Rowan stated the 2010 premium was \$16,376 and the 2009 premium was 14,575.

Mr. Frimerman moved, Mr. Salmon seconded the motion to approve the insurance coverage with OTARMA, at an annual cost of \$18,823.00 effective January 1, 2011.

ITEM 158-10 Approval of I.R.S. Mileage Rate for 2011

Mr. Frimerman moved, Mr. Salmon seconded the motion to approve the following resolution:

Whereas, the Oxford Township Trustees has chosen not to procure a health care plan under R.C. 505.60 and has chosen instead to reimburse a township officer or employee for each out-of-pocket premium attributable to the coverage provided for them for insurance benefits described in R.C. 505.60(A) that the officer or employee otherwise obtains;

Whereas, the Oxford Township Trustees, Fiscal Officer, and Full-Time employees are eligible for reimbursement;

Whereas, the maximum reimbursement per person shall not exceed \$1,000/per month, to cover both the officer/employee and his/her immediate dependents, if any.

Whereas, reimbursement shall only be made for premiums associated with health care including benefits for hospitalization, surgical care, major medical care, medical care, and prescription drugs. Reimbursement shall not be made for disability, dental care, eye care, long-term care as described in R.C. 124.841, or sickness and accident insurance.

Now, therefore, be it resolved, that the Oxford Township Trustees amend its previous resolutions regarding reimbursement of health care premiums to comply with the recent amendment to R.C. 505.601 by the passage of HB458.

# **Emergency Management Meeting**

 Mr. Salmon reported on his last EMA meeting. Mr. Salmon stated that Townships historically haven't had to contribute where City government has had to contribute .40 cents per person with the municipality. Mr. Salmon stated a proposal is under consideration that would include Townships at .20 cents beginning in 2012, .43 cents in 2013 and .46 cents in 2016. Mr. Salmon stated Oxford Township's contribution would be \$524.40 in 2012 and \$1,206.12 in 2016. Mr. Salmon stated that concerns were expressed over the amount of revenue it would generate so other proposals may be presented spreading the cost more evenly among jurisdictions. Mr. Salmon stated Townships wishing not to contribute are mandated by law to create their own EMA.

Community Improvement Corporation (CIC)

• Mr. Frimerman stated a letter was sent to the City requesting annexation for the proposed Tech Park on St. Rt. 73. Further, Mr. Frimerman stated the marketing study is moving forward and the CIC is preparing to approve a few revolving loans.
